Carry Downey gave us a brief update on ATT Phone issues coming for those of us with landlines. Encourages us to contact her to join her in fighting this move.

Dr. Fern Nelson shared about new exhibit at Coronado Historical Society. Called An Island Looks Back, covering our Black Community's history in Coronado. She reminded us there were over 400 Black community members in the 1940s. Exhibit will be opened at least until May 2024.

Doug Case from Toni Atkins office shared an update. Legislature currently working on budget deficit expected in CA this year. Senator Atkins terms out but will be a candidate for Governor in 2026. Challenge is to get her more well known throughout the state.

Danny Avithia from San Diego Dem Club Committee, running for SDCDP Central Committee. He asks for our support.

Alexia Palacios Peters, CUSD Trustee, new President of School Board. Gave us update of flood damage at Village Elementary School, Middle School and EDEC school. She reminded us two seats coming up; Antrim and Cavanaugh's seats.

Rep from 55th district also shared briefly.

Ryan Trabuco San Diego Democrats for Equality who led protest of Awaken "Church" trying to get started in Coronado spoke briefly.

Program: Introduced by Carol Sandiford

Jeanne Weidner of League of Women Voters to discuss: Threats to our Democracy and the pros and cons of Prop. 1, The Mental Health Bond which will be on the March 4 primary ballot.

Jeanne Weidner gave us a brief review of the origins of the League of Women Voters, followed by an informative slide show outlining the current challenges to our Democracy and where the LWV is currently focusing.

Remainder of Minutes

Finishing up LWV:

One key aspect of it is that it's going to shift approximately 140 million of the annual mental health funding currently available to counties that they use for community based mental health services. And that would be transferred to the state to help support its mental health services and build facilities for them.

Several questions and clarifications.

So they estimate that the bonds would pay for building 6800 treatment beds and new facilities and under 4300 housing units, and half of these would go to veterans experiencing homelessness. Support for the measure comes from the governor of course and of course our most of our legislators who voted for it. And they state that this is going to pay for needed housing who are for people who are chronically unhoused and people with mental or behavioral challenges. It will be used for construction and rehabilitation about other facilities

for these people. And they claim that it provides treatment over incarceration. The opposition to it claims that it reduces local funding for community and evidence based research and they feel that this has been accessible and effective. They feel that it would also forced treatments that are not effective and that are associated with a higher suicide rate. They believe that this money will be borrowed simply to build new facilities. We could actually have some of the problems that we had, when we had we had a lot of institutionalization of the mentally, mentally ill several decades ago, and they felt that they feel that these housing units would have minimal impact on reducing homelessness.

Question about forced treatment. Speaker clarifies that her wording is taken directly from the state.

So you will see this question on your ballot. Should a greater share of the Mental Health Services Act funding be used and new bonds issued to build treatment facilities and housing for people with mental illness? And yes, vote means that these bonds should be issued and the money should be shifted until about means sanctions essentially stay the way they are with the current funding that we have for these mental health problems. So I don't know if I should stop there. i i And most of you are not probably in in the city of San Diego. Anyway, there's only one measure for San Diego and it's pretty straightforward. So okay, thank you very much.

Chair Susan Marrinan thanks speaker and adds that LWV has a good website; encourages everyone to vote in the primary March 5 and November 7 & 5.

Changes order of Committee Reports saying that Carol will send around a sheet for programs so that people can add ideas and suggested speakers.

Danny, from Council of Clubs, adds that the council keeps a list of suggested speakers.

Carol Stanford, nominating committee. Hands out sheet; adds looking for volunteers as the committee has no chair.

Skips ahead to Nominating Committee update:

Describes the work of the committee which this year is to elect president and vice president in even years. IN odd years, treasurer and secretary.

Pitch to volunteers:

"So we have two openings and the nominating committee has was appointed in January. And we have worked very hard to develop a slate for you. But it occurred to us we really don't know all of you, particularly the newer members who we haven't had a chance to talk to her say What are you interested in? You know, are you a CPA who would like to buy the Treasury room Treasurer's Report. And so there's, we really hope that those of you who are new or new ish, and those of you who have been around if you're interested in being an officer of this organization, and you have skills that you have to offer and we are all volunteers that you let us know that you contact Frank who's here you contact me and say, Well, you know, I I'm interested in this, what happens here or I think I could be a pretty good secretary. So put me

down for consideration. Maybe I'll think about it next year when that office is open. So the office of president is the duties are in our bylaws, and the office of president and twelves being the face of the club, the president can go to the Central Committee meetings as an associate delegate, can attend the south area caucus, as a delegate, and we support grass roots. And you're gonna hear from our grassroots share and then the country means grass roots organization. These are people on the ground who are working hard to do what to elect Democrats and to support democratic principles and values. And that's the whole point of this club, which is a political club. We are a 527. So you might think, Well, gee, I don't know how to fit out but I'm here to tell you that Marely Ramirez was not on the board before she became president. Bill singer was not on the board became before he became president. I knew one person when I walked into this room, and 2017 or 18, somewhere around in there. And I was asked to be on the nominating committee, and I thought, well, I don't know anybody. But they want me to do that but okay, they asked and I had the time. The next thing I knew, I was writing, I was on the slate to be Secretary. He said, Would you mind leaving the room and I came back. They said, Well, we think you should be secretary. And so that was my history, and I didn't know anybody. I knew one single person in this whole club. So don't be shy. Don't be shy at all. The Vice President's duties are to stand in for the President. Like today. And to attend the council had meetings."
